ORDER

In pursuance of letter No. 21/31/2022-ESTABLISHMENT dated 03.07.2023 from Director to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Central Mines Planning and Design institute Limited (CMPDIL), Shri Achyut Ghatak, General Manager, Coal India Limited (CIL) has been appointed as Director (Technical) in Central Mines Planning and Design institute Limited in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000 – 2,90,000/- for a period with effect from the date of his assumption of charge on or after 01.10.2023 of the post till the date of his superannuation i.e 31.03.2028 or until further orders, whichever is earlier subject to the condition that after the expiry of the first year, the performance of Shri Ghatak will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shri Ghatak takes over charge of the said post. However, his appointment as Director (Technical), CMPDIL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.

As stipulated in DPE's O.M. No. 18(21)/98-GM-GL-73 dated 20th October, 2005, if Shri Ghatak does not join the post, he shall be debarred for a period of two years from the date of offer of appointment, from being considered for Board Level posts in any CPSE. The debarment would be applicable to all CPSE's other than the one to which the candidate belongs.

Detailed terms and conditions of appointment of Shri Ghatak as Director (Technical), CMPDIL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

The appointment of Shri Ghatak as Director (Technical), CMPDIL is subject to the final outcome of WP(S) No.10800/2019 in the High Court of Chhattisgarh.

Shri Achyut Ghatak will assume the charge of the post of Director (Technical), CMPDIL in Schedule 'B' of CPSE in the pay scale of Rs. 1,60,000 – 2,90,000/- on or after 01.10.2023 and submit his joining report to Chairman-cum-Managing Director, CMPDIL under intimation to Chairman-cum-Managing Director, Coal India Limited and Ministry of Coal.
