In pursuance of letter No. 21/30/2022-ESTABLISHMENT dated 03.07.2023 from Director to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Central Mines Planning and Design institute Limited (CMPDIL), Shri Satish Jha , General Manager, Northern Coalfields Limited (NCL) has been appointed as Director(Technical) in Central Mines Planning and Design institute Limited in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000 - 2,90,000/- for a period with effect from the date of his assumption of charge on or after 01.09.2023 of the post till the date of his superannuation i.e 30.11.2027 or until further orders, whichever is earlier subject to the condition that after the expiry of the first year, the performance of Shri Jha will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.
