## ORDER

In pursuance of letter No. 21/17/2020-ESTABLISHMENT (BA) dated 05-02-2024 from Deputy Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Coal India Limited (CIL), Shri Mukesh Agrawal, Executive Director (ED), NLC India Limited (NLCIL), has been appointed as Director(Finance) Coal India Limited (CIL) in Schedule 'A' of the CPSE, in the scale of pay of Rs.1,80,000-3,40,000/- for a period of five years with effect from the date of his assumption of charge of the post, or till the date of his superannuation or until further orders, whichever is earlier subject to the condition that after the expiry of the first year, the performance of Shri Agrawal will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shri Agrawal takes over charge of the said post. However, his appointment as Director (Finance), CIL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.

As stipulated in DPE's O.M. No. 18(21)/98-GM-GL-73 dated 20<sup>th</sup> October, 2005, if Shri Agrawal does not join the post he shall be debarred for a period of two years from the date of offer of appointment, from being considered for Board Level posts in any CPSE. The debarment would be applicable to all CPSE's other than the one to which the candidate belongs.

Detailed terms and conditions of appointment of Shri Agrawal as Director (Finance), CIL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

The appointment of Shri Agrawal is subject to the final outcome of WP(S) No.10800/2019 in the Hon'ble High Court of Chhattisgarh.

Shri Mukesh Agrawal will assume the charge of the post of Director (Finance), CIL in Schedule 'A' of CPSE in the pay of Rs. 1,80,000-3,40,000/- and submit his joining report to Chairman-cum-Managing Director, CIL under intimation to Ministry of Coal.
