OFFICE MEMORANDUM

Subject: Relaxation on Global Tender Enquiry (GTE) under Rule 161(iv) of General Financial Rules (GFRs) 2017 for procurement of raw materials.

The undersigned is directed to refer to Department for Promotion of Industry & Internal Trade (DPIIT) OM No. P-45021/196/2020-PP (BE) (E-46734) dated 23.03.2021 enclosing Approach paper of Bharat Heavy Electricals limited (BHEL) dated 16.02.2021. BHEL has requested that raw materials like Nickel, Chromite sand, Low carbon ferro Chrome, Metallic Manganese flakes etc, which are not available in the country may be exempted from restrictions of GTEs. DPIIT has also recommended that such raw materials, which are not available in country (or not available of appropriate quality/ grade), may be allowed to be procured through GTEs. DPIIT has further stated that similar proposal has been also received by them from SAIL, Ministry of Steel as well.

- 2. The matter was referred to Ministry of Micro, Small & Medium Enterprises (MoMSME), who have now stated vide their OM No. 21(3)/2020-MA(Pt.-1)(e-20336) dated 10.01.2022 that MoMSME does not have any objection to call GTEs for such items subject to condition that "No MSE in country is engaged in manufacturing of the such items".
- 3. In view of all above, it has been now decided that procurement of raw materials, like above, which are not available in country (or not available of requisite quality/ grade) may be done through GTEs with the approval of Secretary of Ministry/ Department concerned.
- This issues with the approval of Finance Secretary.
