ORDER

In pursuance of letter No. 21/3/2021-ESTABLISHMENT dated 19.10.2022 from Under Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Central Mine Planning & Design Institute Limited (CMPDIL), Shri Ajay Kumar, Additional General Manager, NTPC Ltd., has been appointed as Director(Technical), Central Mine Planning & Design Institute Limited (CMPDIL), in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/- with effect from the date of his assumption of charge of the post till the date of his superannuation i.e 31.07.2027, or until further orders, whichever is earlier subject to the condition that after the expiry of the first year the performance of Shri Kumar will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shri Kumar takes over charge of the said post. The debarment would be applicable to all CPSE's other than the one to which the candidate belongs.

Detailed terms and conditions of appointment of Shri Kumar as Director (Technical), CMPDIL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

The appointment of Shri Ajay Kumar is subject to the final outcome of WP(S) No.10800/2019 in the High Court of Chhattisgarh.

Shri Ajay Kumar will assume the charge of the post of Director (Technical), CMPDIL in Schedule 'B' of CPSE in the pay scale of Rs. 1,60,000-2,90,000/- and submit his joining report to Chairman-cum-Managing Director, CMPDIL under intimation to Chairman-cum-Managing Director, Coal India Limited and Ministry of Coal.
