ORDER

In pursuance of letter No. 21/7/2023-ESTABLISHMENT-(BA) dated 31.01.2024 from Deputy Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Western Coalfield Limited (WCL), Shri Jai Prakash Dwivedi, Director(Technical), WCL has been appointed as Chairman-cum-Managing Director, Western Coalfield Limited (WCL) in Schedule 'B' of the CPSE, in the scale of pay of Rs. 1,80,000-3,20,000/- with effect from the date of his assumption of charge of the post, on or after 01.02.2024, till the date of his superannuation i.e. 31.01.2026 or until further orders, whichever is earlier subject to the condition that after the expiry of the first year, the performance of Shri Dwivedi, will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shri Dwivedi takes over charge of the said post. The debarment would be applicable to all CPSE's other than the one to which the candidate belongs.

Detailed terms and conditions of appointment of Shri Dwivedi as CMD, WCL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

The appointment of Shri Dwivedi is subject to the final outcome of WP(S) No.10800/2019 in the High Court of Chhattisgarh.

Shri Jai Prakash Dwivedi will assume the charge of the post of CMD, WCL in Schedule 'B' of CPSE in the pay of Rs. 1,80,000-3,20,000/- and submit his joining report to Chairman-cum-Managing Director, Coal India Limited under intimation to Ministry of Coal.
