Dear Sir,

You were awarded the composite work for "OB Removal, Loading & Transportation of Coal and other associated works" at Mahamaya OC Project, Bhatgaon Area, SECL against e-NIT No. SECL/BSP/CMC/BHT/Mahamaya-Comp/e-T/24-25/GeM-160 dated 19.03.2025.

Despite multiple letters and reminders, you had failed to submit PSD and APSD as required by LoA and Terms and Conditions of the NIT, which indicated your unwillingness to fulfil the contractual obligations.

Consequently, the awarded work was cancelled by SECL, and you were debarred for a period of 02 years from bidding in future tenders in SECL, vide letter no. SECL/GM(BHAT)/GM/2025-26/1225 dated 30.01.2026.

It is further to note that you were also banned from participation in future tenders of Northern Coalfields Limited (NCL) and Mahanadi Coalfields Limited (MCL) for a period of 2 (two) years with effect from 31.05.2021 & 24.08.2021 respectively due to non-submission of PSD & APSD.

However, neither any authorized representative of the firm appeared for the hearing nor was any request for adjournment received before the date of the hearing.

In view of the above, M/s DNC Infrastructure Private Limited, Hyderabad (PAN: AAECD6227F) is debarred from participation in future tenders in CIL & its subsidiaries for a period of 2 (two) years from the date of issuance of the Order, except for SECL where the firm is already debarred for a period of two years, i.e. till 29.01.2028.
