Consequent upon qualifying in the Computer Based Test (CBT) held on 31-July-2021 against Notification No 7475 dated 16-Oct-2015 for promotion / selection from Non – Executive to Executive cadre in **System** Discipline and subsequent Interviews in respect of shortlisted candidates held on 27-Nov-2021 and DPC held on 28-Dec-2021 at CIL Hq. Kolkata, following departmental employees are hereby **provisionally** promoted / selected from Non-Executive to Executive Cadre to the **post of Senior Officer (System) in E2 Grade** in the scale of pay of ₹ 50,000 – 1,60,000/- and other allowances as admissible subject to submission of requisite documents (i.e. Final Degree Certificate) within a period of 06 months' time from the date of issuance of this order. On promotion / selection to the post of Sr. Officer (System) in E-2 grade in Executive Cadre, they will be on training / probation for a period of one year at the first instance. If their performance during the training /probation period is not found satisfactory, their training /probation period may be extended or they may be reverted to their substantive post in non-executive cadre.

The promotion / selection will be effective on and from the date they assume charge of the promoted / selected post at the new place of posting. On assumption of the charge for the post of Sr. Officer (System), they will be entitled to notional seniority and notional fixation at par with departmental employees promoted from Non- Executive to Executive cadre in System discipline for the post of Sr. Officer (System) in E-2 Grade vide order No. CIL:Rectt:prom/selection:System:3801 dated 21-Feb-2022 and consequent upon such notional seniority, Shri Sinha will be placed below Shri Anish Kuriakose and above Smt. Vandana Iyengar & Shri Sharma will be placed below Shri Ramesh Chandra Singh and above Shri Dharmendra Kumar Verma. However, the actual financial benefit shall accrue to them only from the date of assumption of charge of the promoted post. In case they fail to join the promoted / selected post **within one month from the date of issue of this promotion / selection order**, the order will automatically stand cancelled.

On promotion / selection to the post of Sr. Officer (System), the above employees will be governed by the Conduct, Discipline and Appeal Rules - 1978 of CIL, as amended from time to time and their service conditions will be same as applicable to the Executive Cadre employees of Coal India Limited and its Subsidiary Companies.

The above employees will furnish their original as well as self-attested copy of certificates in support of their Educational / Professional Qualifications and Caste Certificate (SC/ST), if any, for verification purpose, at the time of joining at their place of posting for record.
