above Shri Rabi Dev Sharma in the merit panel. However, the actual financial benefit shall accrue to them only from the date of assumption of charge of the promoted post. In case they fail to join the promoted / selected post within one month from the date of issue of this promotion / selection order, the order will automatically stand cancelled.
