Sub: Modification in Model FSA for State Nominated Agencies (SNA) - Corrigendum

Dear Sir,

This is reference to letter no. CIL/M&S/47252(New Pol)/103 dated 07.03.2019, vide which a revised model FSA for the SNAs was circulated.

It has come to notice that in clause no. 21.1 of the said model FSA, due to an inadvertent error, *Schedule- II* has been mentioned instead of *Schedule- III*. Accordingly, the clause no. 21.1 shall stands modified as below:

Clause no.	Existing Provision	Modified Provision
21.1	The quality of the Coal to be supplied from the mines of the Seller as far as possible shall be within the specifications as per Schedule-II to this Agreement. The Seller shall take all reasonable steps to remove stones above 250mm (in size), shale and extraneous matters before the loading of the coal. Complaint, if any, regarding the quality of coal shall be made by the Purchaser giving specific details of the consignment to the GM (M&S) of the Seller.	The quality of the Coal to be supplied from the mines of the Seller as far as possible shall be within the specifications as per Schedule-III to this Agreement. The Seller shall take all reasonable steps to remove stones above 250mm (in size), shale and extraneous matters before the loading of the coal. Complaint, if any, regarding the quality of coal shall be made by the Purchaser giving specific details of the consignment to the GM (M&S) of the Seller.
