On promotion/selection to the post of Sr. Officer (Mining) in E-2 grade in Executive Cadre, they will be on probation for a period of one year at the first instance. If their performance during the probation period is not found satisfactory, their probation period may be extended or they may be reverted to their substantive post in non-executive cadre.


Candidates against whom (#) is mentioned, their original 2nd Class MMCC is under process for verification by DGMS, Dhanbad. Their promotion/selection order is being issued subject to submission of an undertaking in Annexure-A. In future, if their 2nd Class MMCC is found to be false/fake/fabricated, their candidature for the post of Sr. Officer (Mining) in E-2 grade will automatically be cancelled followed by recovery of salary and appropriate disciplinary action will be initiated against them under the services rules of the Company.

The promotion/selection will be effective on and from the date they assume charge of the promoted/selected post at the new place of posting and Executive establishment of the concerned subsidiaries shall obtain the EIS No. through SAP from Recruitment Division, CIL. In case the employee fails to join the promoted/selected post within one month from the date of issuance of this promotion/selection order, the order will automatically stand cancelled.

On promotion / selection to the post of Sr. Officer (Mining), the above employees will be governed by the Conduct, Discipline and Appeal Rules - 1978 of CIL, as amended from time to time and their service conditions will be same as applicable to the Executive Cadre employees of Coal India Limited and its Subsidiary Companies.

The above employees will furnish their original as well as self-attested copy of certificates in support of their Educational / Professional Qualifications / 2nd Class MMCC and Caste Certificate (SC/ST), if any, for verification purpose, at the time of joining at their place of posting for record.
