### NOTICE

#### **Sub: Draft Rationalized Matrix- Linkage Rationalization (3<sup>rd</sup> Round)**

Based on MOC's 'Linkage Rationalization' policy dated 15.05.2018 and further guidelines dated 16.01.2023 & 26.04.2023, SOP for Linkage Rationalization was formulated and uploaded in CIL's website on 14.06.2023.

In terms of the said SOP, CIL floated EOIs on 17.08.2023 for conducting 'Third Round of Linkage Rationalization' for both State / Central Gencos and IPPs. Apart from Talwandi Sabo Power Limited (TSPL), no other Genco / IPP submitted EOI. TPSP vide EOI dated 14.09.2023, sought transfer of existing linkage quantity of 6.72 MTPA from MCL to SECL.

As per the aforesaid MOC's policy and CIL's SOP, data on coal dispatch to various power houses was required to be sent to CEA for determining rationalized quantity at new sources and corresponding savings in transportation cost. Accordingly, for TSPL, dispatch data for FY 2022-23 received from SECL and MCL, were sent to CEA on 09.10.2023.

CEA vide letter dated 19.10.2023 and subsequent mail dated 27.10.2023, indicated that linked quantity of 67,20,000 tonne at MCL is equivalent to 54,43,826 tonne of rationalized quantity at SECL and this would result in savings in electricity cost @ Rs 0.60 per kWh.

Further, in terms of MOC's policy and CIL's SOP on 'Third Round of Linkage Rationalization', a meeting of 'Action Group' was held on 31.10.2023 during which the following draft rationalized matrix has been agreed:
