Sub: Obtaining Affidavit from Power Producers receiving coal under FSA regarding utilization of coal supplied for generation and supply of power as per PPA

The Ministry of coal vide Letter No. F.No 23011/84/2012-CPD dated 24.9.2015 (copy enclosed) informed that since the coal supplied to power utilities against FSA at a price notified by CIL, it is ensured by coal companies that coal supply is only to the extent of and coterminous with the long term Power Purchase Agreements (PPAs) that the power companies have signed with the DISCOMs.

CIL is therefore advised to obtain affidavits from the power generating companies, which are the FSA holders, affirming that the coal supplied has been used (by the power plant) as per Long Term PPA and the power generated using this coal has been supplied to the DISCOMS as per PPA. CIL has been advised to develop a format for this affidavit. The affidavit has been advised to be obtained for the year 2014-15 and for the period 01.04.2015 to 30.09.2015.

Accordingly, a draft Affidavit has been evolved at CIL, which has been vetted by CIL, Legal Department. You are requested to notify the concerned Power Producers having FSA with your company to furnish the Affidavit at the earliest to the Supplying coal company. Action taken in this regard may be intimated to this office.

3. That in case at any stage it is found that the Power Generated out of the coal supplied under the subject FSA has not been supplied to the DISCOM(s)/PTC(s) under the long term PPA. We shall be liable for actions as may be available to the Seller under the FSA considering such failure as 'breach' in terms of the Fuel Supply agreement and for any other actions taken by any other authority including the State/Central power regulator.
