विषय: Aligning definition of "Conflict of Interest" clause of CMM with DoE manuals.

महाशय,

The subject issue was deliberated in 314th meeting of CIL CFDs held on 04.08.2023. The amendments approved in the "Conflict of Interest" clause of CMM as communicated by Company Secretary, CIL vide letter No.CIL:XI(D):04135:2023:30871 dated 09.08.2023 is as follows:-

Clause No.	Existing provision of CMM	Approved Clause
Annexure-III(Proforma of CIPP) of Chapter-3 & 6 and Annexure-IA(Proforma of CIPP) of Chapter-2	"Conflict of interest": A Bidder may be considered to have a Conflict of Interest with one or more parties in this bidding process, if: a. they have controlling partner(s) in common; or b. they receive or have received any direct or indirect subsidy/financial stake from any of them; or c. they have the same legal representative/agent for purposes of this bid; or d. they have business relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another Bidder; or e. a Bidder or any of its affiliate participated as a consultant in the preparation of the design or technical specification of the contract that is the subject of the bid; or f. in case of a holding company having more than one Subsidiary/Sister Concern having common business ownership/management only one of them can bid. Bidders must proactively declare such sister/common business/management in same/similar line of Business;	"Conflict of interest": Participation by a bidding firm or any of its affiliates that are either involved in the consultancy contract to which this procurement is linked; or if they are part of more than one bid in the procurement; or if the bidding firm or their personnel have relationships or financial or business transactions with any official of procuring entity who are directly related to tender or execution process of contract; or improper use of information obtained by the (prospective) bidder from the procuring entity with an intent to gain unfair advantage in the procurement process or for personal gain.
