Sub: Amendment in the Milestones of LOA for Cement Plants

Dear Sir(s).

The milestones of LOA for Cement plants have been amended as per approval by CIL Board in its 254th Meeting held on 30th January 2010, subject to confirmation from MOC.

Subsequently, the matter was taken up with MOC and after due interaction with DIPP (Ministry of Commerce and Industry) the issues in terms of DIPP suggestions were placed for consideration of the CIL Board. CIL Board in its 263rd Meeting held at New Delhi on 14th December 2010, accorded the approval to the following:

- 1. Cement Companies shall be given 90 days time to comply with the revised milestones after these milestones are notified and
- 2. To evolve a procedural mechanism for review/redressal of any difference with regard to documents submitted in compliance of milestones of the cement companies as well as for other SLC(LT) consumers i.e., Power and Sponge Iron sectors by Director (Marketing). Board also advised Director (Marketing) to dispose of the appeal within a reasonable time.

So far as signing of FSA for capacity lower than the capacity recommended by SLC(LT) for cement plants, the terms and conditions as mentioned in the MOC letter no. 23011/81/2007-CPD(Pt-II) dated 13th December, 2010 (copy enclosed as Annexure-A) shall be applicable.

A copy of the approved modified milestones of LOA for Cement plants in enclosed as Annexure-B for taking further necessary action.

Modification in the milestones for "Letter of Assurance" (LoA) for Cement

Plants-reg

Sir.

I am directed to refer to your letter No. CIL/CMO/47252/New Pll)/559 dated 25.8.2010 on the above mentioned subject In para (4) of your letter it was proposed that the suggestion of DIPP for signing of FSA for capacity lower than the capacity recommended by the SLC(LT) for Cement Plants can be accepted, if a dispensation is given by the Ministry of Coal in this regard.

- 2. The matter has been examined in this Ministry and the Competent Authority has approved the proposal of DIPP for accepting lower capacity of cement plants as compared to the capacity recommended by the SLC(LT), subject to the following conditions:-
- i) Reduction in total capacity/unit size or reduction of number of units for which LoA has been authorized will be permitted, provided a request is made in writing to coal companies/Ministry of Coal, to be duly recommended by DIPP within the stipulated validity period of LoA. This permission will be one time permission and no further request for the said capacity/unit size revision/reduction/enhancement would be permitted.
- (ii) The coal quantity would be worked out by CIL/SCCL on the basis of revised reduced capacity and unit size and would be governed by the existing norms applicable for the revised reduced capacity and unit size and subject to fulfilment of milestones FSA for the approved revised reduced quantity would be concluded by the concerned coal company.
- ii) The reduction in total capacity or unit size will be permissible subject to pro-rata enforcement of Bank Guarantee and in default of approved reduced capacity, enforcement of full Bank Guarantee for the remaining amount as applicable under Ministry of Coal guidelines No. 23011/47/2009-CPD dated 1.7.2009 (available on available on MoC website. (www.coal.nic.in).

- iv) The approved revised capacity or unit size would be considered for milestones purposes.
- v) No refund of processing fee will be entertained on account of the proposed reduction If the applicant decides to enhance the capacity in future, the applicant will apply afresh for the same as per extant instructions of Ministry of Coal.
- 3. CIL is requested to take necessary action accordingly and intimate action taken in the matter to this Ministry.
- 4. CIL is also requested to apprise this Ministry of the action taken by CIL on para(1) to (3) of their letter dated 25.8.2010 referred above.
