If a candidate fails to report for Document Verification (DV) and/or fails to produce the requisite documents on the scheduled date of DV, he/she shall not be permitted to appear for the Initial Medical Examination (IME), and his/her candidature shall stand cancelled forthwith without any further notice. Further, if a candidate does not meet the prescribed medical standards during IME and is declared “Unfit for Employment” in Coal India Limited, his/her candidature shall also be cancelled accordingly.
