
Sub: Payment of Industrial Dearness Allowance (IDA) at revised rate @ 54.1% in respect of Board Level & Below Board Level Executives of Coal India Limited w.e.f 01.04.2026.

In terms of item No. V of O.M. No. CIL/C5A(PC)/Pay Revision 2017/2972 dated 08.08.2018 Dearness Allowance is payable from 1st January, 1st April, 1st July and 1st October in every year based on price increase above Quarterly Index Average 277.33 points as on 01.01.2017.

As per OM No. W-02/0037/2025-DPE(WC)/FTS-14505 dated 24.04.2026 issued by Joint Director, Government of India, Ministry of Finance, Department of Public Enterprises and in reference to para 7 and Annexure-III(B) of DPE's OM dated 03.08.2017 wherein the rates of IDA payable to the Board level and below Board level executives and non- unionized supervisors of CPSEs have been indicated, the rates of IDA payable to the executives and non- unionized supervisors of CPSEs following 2017 Pay Scales has been revised is as under:

IDA rate has been revised to 54.1% payable w.e.f. 01.04.2026

The above revised Industrial Dearness Allowance (IDA) rate @ 54.1% w.e.f. 01.04.2026 would be applicable in the case of IDA employees who have been allowed revised pay scales (2017) as per DPE O.Ms. dated 03.08.2017, 04.08.2017 & 07.09.2017.
