ORDER

In pursuance of letter No. 21/2/2021-ESTABLISHMENT dated 14.05.2022 from Under Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Western Coalfield Limited (WCL), Shri A.K. Singh, General Manager (GM), Mahanadi Coalfields Limited(MCL) (Presently posted as General Manager in WCL) has been appointed as Director(Technical), Western Coalfields Limited (WCL) in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/- (revised) with effect from the date of his assumption of charge of the post till the date of his superannuation, i.e. 31.07.2025, or until further orders, whichever is earliest subject to the condition that after the expiry of the first year the performance of Sri Singh will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shri Singh takes over charge of the said post. However, his appointment as Director (Technical), WCL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.

The appointment of Shri A.K. Singh is subject to the final outcome of WP(S) No.10800/2019 in the High Court of Chhattisgarh.

Shri A.K. Singh will assume the charge of the post of Director (Technical), WCL in Schedule 'B' of CPSE in the pay of Rs.1,60,000-2,90,000/-(revised) and submit his joining report to Chairman-cum-Managing Director, WCL under intimation to Chairman-cum-Managing Director, CIL and Ministry of Coal.
