### कार्यालय आदेश

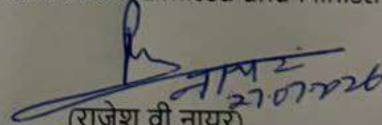
In pursuance of letter No. 21/19/2025 ESTABLISHMENT dated 27.07.2026 from Section Officer to the Govt. of India, Ministry of Coal, New Delhi, conveying the approval of the President and in pursuance of Articles of Association of Eastern Coalfields Limited (ECL), Shri Chitrnanjan Kumar, General Manager, Central Coalfields Limited (CCL), has been appointed to the post of Director (Technical), Eastern Coalfields Limited, in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/- with effect from the date of his assumption of charge of the post till the date of his superannuation i.e 30.11.2029 or until further orders, whichever is earliest subject to the condition that after the expiry of the first year the performance of Shri Chitrnanjan Kumar, will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of his tenure.

His appointment to the said post will be effective from the date on which Shri Chitrnanjan Kumar takes over charge of the said post. However, his appointment as Director (Technical), ECL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.

As stipulated in DPE's O.M. No. 18(21)/98-GM-GL-73 dated 20<sup>th</sup> October, 2005, if Shri Chitrnanjan Kumar does not join the post he shall be debarred for a period of two years from the date of offer of appointment, from being considered for Board Level posts in any CPSE. The debarment would be applicable to all CPSE's other than the one to which he belongs.

Detailed terms and conditions of appointment of Sri Chitrnanjan Kumar, as Director (Technical), ECL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

Shri Chitrnanjan Kumar will assume the charge of the post Director(Technical), ECL in Schedule 'B' of CPSE in the pay of Rs.1,60,000-2,90,000/- and submit his joining report to Chairman-cum-Managing Director, ECL under intimation to Chairman-cum-Managing Director, Coal India Limited and Ministry of Coal.
