- 1) **Pay Scale of the Post**
Rs. 1,80,000-3,40,000 p.m. + PRP + other benefits as admissible.
- 2) **Eligibility and Qualifications/Experience**
 - I. **Age** Minimum 45 years as on the date of advertisement
 - II. **Employment Status:**
The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity — and not in a contractual including tenure/ad-hoc capacity - in one of the following:-
 - (a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
 - (b) Central Government including the Armed Forces of the Union and All India Services;
 - (c) State Public Sector Enterprise (SPSE) where the annual turnover is *Rs 10,000 crore or more;
 - (d) Private Sector company where the annual turnover is *Rs 5,000 crore or more.
(*The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)
 - iii. **Qualification and Experience:**
Qualification: The applicant should be a Chartered Accountant or Cost Accountant or a full time MBA/PGDM course having specialization in Finance with good academic record from a recognized University/Institution. Preference would be given to Chartered Accountant.
Experience: The applicant should have at least five years of cumulative experience at a senior level during the last ten years in the area of Corporate Financial Management / Corporate Accounts in an organization of repute. Preference would be given to candidates from Maharatna / Navaratna / Listed Companies. Experience in Coal/ Steel/ Mining/ Energy sector will be an added advantage.
 - iv. **Pay Scale**
 - a) **For Officers of CPSEs**
Candidates should, on the date of advertisement, be working in the Eligible scale of pay as per Job description.
 - b) **For Officers of Central Govt./Armed Forces of the Union/All India Services**
