ORDER

In pursuance of letter No. 21/26/2022-ESTABLISHMENT dated 28.06.2023 from Director to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Coal India Limited(CIL), Shri P M Prasad, Chairman-cum-Managing Director, Central Coalfields Limited(CCL) has been appointed as Chairman-cum-Managing Director in Coal India Limited in Schedule 'A' of the CPSE, in the scale of pay of Rs.2,00,000 - 3,70,000/- with effect from the date of his assumption of charge of the post on or after 01.07.2023 till the date of his superannuation i.e 31.10.2025 or until further orders, whichever is earlier subject to the condition that after the expiry of the first year, the performance of Shri Prasad will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shri Prasad takes over charge of the said post. However, his appointment as CMD, CIL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.

As stipulated in DPE's O.M. No. 18(21)/98-GM-GL-73 dated 20th October, 2005, if Shri Prasad does not join the post, he shall be debarred for a period of two years from the date of offer of appointment, from being considered for Board Level posts in any CPSE. The debarment would be applicable to all CPSE's other than the one to which the candidate belongs.

Detailed terms and conditions of appointment of Shri Prasad as CMD, CIL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

The appointment of Shri P M Prasad as CMD, CIL is subject to the final outcome of WP(S) No.10800/2019 in the High Court of Chhattisgarh.

Shri P M Prasad will assume the charge of the post of Chairman-cum-Managing Director, Coal India Limited(CIL) in Schedule 'A' of CPSE in the pay scale of Rs. 2,00,000 - 3,70,000/- on or after 01.07.2023 and submit his joining report to the Secretary(Coal), Govt. of India, Ministry of Coal.
