ORDER

In pursuance of letter No. 21/27/2021-ESTABLISHMENT dated 22.08.2022 from Under Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Bharat Coking Coal Limited (BCCL), Shri Uday A Kaole, General Manager(Mining), Western Coalfield Limited (WCL) has been appointed as Director(Technical). Bharat Coking Coalfield Limited (BCCL) in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/- with effect from the date of his assumption of charge of the post till the date of his superannuation, i.e.31.01.2027, or until further orders, whichever is earlier subject to the condition that after the expiry of the first year, the performance of Sri Kaole will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.
