Minutes of meeting held on 27.10.2014, taken by D(T)P&P, on Sampling and analysis by 3rd party Agency engaged by Power utilities/IPP.

A meeting was taken by D(T)P&P, BCCL, Mr. A. Sarkar with representatives of power utilities/ IPP in Conference Hall Level-III, BCCL, Koyla Bhawan, Koyla Nagar on 27.10.2014 to discuss 'sampling and analysis at loading point of BCCL by 3rd party Agency engaged by Power utilities/IPP in reference to the 'Standard Operating Procedure , (SOP), circulated by CIL. A notice was given for the meeting which was also uploaded on BCCL website, a copy of the notice is enclosed for ready reference. Power utilities were also informed through SMS. The meeting was also attended by ASMs of nine areas from where coal is dispatched to power utilities. The list of participants is given in Annexure-I.

At the outset, GM (QC) welcomed all consumers' representatives, who attended the meeting and briefed about the agenda of the meeting.

D(T)P&P, BCCL informed that the 'Standard Operating Procedure , (SOP), circulated by CIL, for Sampling and analysis at loading points of BCCL by 3rd Party Samplers to be engaged by Power Utilities/ IPP was sent to all power utilities / IPP . D(T)P&P requested all the representative(s) of Power utilities/ IPP to give the status of implementation of 3rd Party Sampling engaged by Power utilities/ IPP at loading points of BCCL. The summarized status as informed by the representative(s) of Power utilities/ IPP is given below:-

1. **DVC:** NIT at corporate level shall be finalized within two months for all power units under DVC i.e., Mejla TPS, DTPS, DSTPS, CTPS, KTPS, BTPS.
2. **WBPDCL:** Process of tendering has not started till date. It shall cover Bakreshwar, Santaldih, Kolaghat, Sagardighi, Bandel TPS.
3. **HPGCL:** NIT at corporate level is under preparation for all power houses under HPGCL. It shall cover Panipat and Hissar TPS taking coal from BCCL. A copy of letter no. 371 Ch-25/HPGCL/CE/Fuel-167 dated 25.10.2014 addressed to GM(S&M), WCL was given seeking clarification which is placed as Annex-II.
4. **NTPC:** NIT at corporate level is under finalisation for all power houses under NTPC. NIT will be floated after receipt of certain clarification from CIL.
5. **BPSCL:** NIT is likely to be floated shortly.
6. **CESC:** NIT not yet finalized.
7. **MPL:** They have appointed M/s SGS India Pvt. Ltd. as their 3rd Party Sampler.

No representatives from UPRVUNL and PSPCL attended the meeting.

HPGCL has suggested for joint third party sampling by both third party samplers. Third Party sampler should test one part of coal sample independently in NABL accredited lab and CIL should test second part of the sample in their own laboratory. In case of any variation in test results, the subsidiary company of CIL will send the referee sample to CIMFR (finalized by CEA).
