With the current stock position, CIL confident of meeting power demand

State-owned miner's output rises 11% in July

With close to 36 million tonnes (mt) of stock at its pithead and around 11.5 mt at various loading points awaiting shipment, Coal India Ltd (CIL) is confident that the current coal stock situation is comfortable to meet the present power demand unless there is a sudden spike.

The total stock at CEA-monitored thermal plants was 29.6 mt as on July 30, up from around 24 mt in the same period last year. Higher supplies from CIL helped power plants build stocks to the tune of 1.04 lakh tonnes per day in July this year, which is also the highest for this fiscal, said a press statement issued by CIL. The stock level of as many as

The stock level of as many as 78 plants is 'critical' (stock which is less than 25 per cent of the normative level) as on July 30 this year, as against 24 plants last year, according to data available on the National Power Portal.

According to Rupesh
Sankhe, analyst at Elara Capital India, there has been a



strong power demand in the last few quarters and CIL will look to ramp up its production and supplies to meet the demand. "We are not getting adequate renewable energy generation and the price of imported coal is very high, making domestic coal highly competitive. CIL will continue to ramp up production and supplies to meet the demand. They have kept some inventory to meet any possible decline in production during monsoon months (August-September), but post-September, we expect production to be ramped up further," Sankhe told Businessi.ine.

Ramping up production

The state-owned miner produced 207.1 mt during April-July, which is almost 24 per cent higher compared with 166.6 mt in the same period last year.

For July alone, CIL produced 47.3 mt, almost 11 per cent more compared with the same period last year, thereby maintaining double-digit growth for fourth months on trot this fiscal, despite the monsoon slowing down its production. Amid the escalated demand from power stations during the current financial year, CIL supplied 199.4 mt to the sector progressive till July'22, a 19 per cent growth compared with 167.3 mt in the same period last year.

According to Ritabrata Ghosh, Assistant Vice-President, ICRA, on the one hand, CIL has been ramping up production and supplies to the power sector, and on the other, production from captive mines is up by nearly 79 per cent in QI FY23 on a year-on-year basis. This should help avert any possible shortfall in supplies.

CII. has been able to maintain a strong production run rate so far this fiscal, and at this rate, it should be able to produce close to 700 mt during the current fiscal. "Their production track record as of now is much better than what most people had expected. If they are able to maintain this run rate, they should be able to touch a production of around 700 mt by the end of this fiscal," Ghosh said.

CIL's record 207.1 MT output in Q1

Kolkata: Coal India (CIL) has produced a record 207.1 million tonnes (MT) of coal during April-July 22, which was 40.5 MTs more than what was produced in the year-ago period.

CIL has stated that for July'22, it produced 47.3 MT of coal, a 4.7 MT jump over the year-ago month logging 11% output growth. The PSU coal behemoth maintained the double-digit streak for the fourth month in a row this fiscal, despite the monsoon slowing down its production. 'Coal Stocks at Power Plants to be Comfortable Post Monsoon'

While there was rapid depletion in summer, last year like crisis unlikely, says CIL chairman

New Delhi: Coal stocks at power plants will be in a comfortable position post monsoon this year and a crisis like last year is unlikely, Coal India (CIL) chairman Pramod Agrawal said in an exclusive interview with ET.

At the beginning of August, power plants had 30 million tonnes (MT) stocks, he said.

Following a sharp rise in power demand in summer and rapid depletion of coal stocks, there were concerns that post-monsoon a coal shortage may emerge again. Coal output declines in monsoon months due to mining diffi-



Only once in FY20 August beginning stocks were higher at 45 mt, but that was in the midst of Covid when coal demand plunged due to lockdown and a general slowdown of industrial activity, he said.

"Apart from the high stocks at plants"

"Apart from the high stocks at plants' end, around 12 mt stock is available at private washeries, goods sheds, ports, and at CIL's sidings awaiting shipment," Agrawal said. "What aggravated the situation last year was that in just a month in August stocks at power plants fell by 11.2 mt. There would not be a recurrence of such oddity unless there is an extraordinary situation," he said.

thermal power stations reached alarmingly low levels as rains hit mining activities. Average coal stock at moni-tored plants plummeted to four days of consumption against the then norm of 21 days, pushing up power prices in spot markets. Coal requirement from CIL to power utilities is pegged at 137 mt for the July-September quarter, entailing a supply of 1.49 mt on an average per day.
