**NOTICE****Subject: Change in Capacity of End Use Plant under Auction of NRS coal linkages Tranche-X for CPP subsector.**

The Tranche X of Linkage Auction is tentatively planned to be conducted from 16.04.2026, beginning with CPP Sub Sector auction in the e-auction platform of M/s MSTC Limited.

Now, in order to provide a scope to the interested registered Bidders of CPP (i.e. bidders earlier registered under CPP subsector under Linkage Auction (non-regulated sector) to revise the capacity or any other related details of their End Use Plants (EUPs), if any, a 07-days window i.e. from 08.04.2026 to 14.04.2026 is provided.

The process to be followed in this regard shall be as under:

- A. The bidders of the above mentioned subsector seeking change/modification in their EUP capacity/relevant details shall intimate about such change to MSTC Ltd., auction service provider from Tranche-X onwards, from their registered e-mail IDs within the 07-days window i.e. from 08.04.2026 to 14.04.2026, along with necessary documents & certification of statutory authority evidencing/approving such change (wherein such change is mentioned) vis-a-vis earlier submitted/relevant documents in this regard in pdf format not exceeding 4 MB (in size).

In case of request for enhancement of Capacity of the Plant, submission of the revised CTO/certificate of Pollution Control Authority allowing the enhanced capacity vis a vis earlier CTO/Pollution control certificate is mandatory along with other relevant documents, else the application may liable for rejection.

- B. Based on the submitted details, necessary updation in the RFP details, if required, shall be made in the auction platform by the auction service provider, subject to completion of registration process in the portal of auction service provider M/s MSTC Limited. The revised details will be effective from Tranche-X.
- C. All the existing FSAs with the concerned EUP are liable to be amended to reflect the changes in capacity/relevant details. The responsibility of intimating such change and submitting the required supporting documents to the concerned Coal Company will be on the bidder. The Bidder shall provide all required supporting documents along with revised undertaking and Affidavit and any additional documents requested by the coal company, evidencing the change, at the time of signing amended/revised FSAs.
- D. The Final Normative Coal Requirement of such bidders may be verified by external verification agency post execution of the FSA.
