In terms of the resolution signed after deliberations held in the 4th meeting of Board of Trustees of CPRMS-NE (Modified) Trust held on 04.08.2023 at CIL (HQ), Kolkata, it is being clarified that the term, "per beneficiary" mentioned in Clause 3.1.2 (b) of CPRMS-NE (Modified) shall be considered as "per CPRMS-NE (Modified) card".
