### CODE OF INTERNAL PROCEDURES AND CONDUCT FOR PREVENTION OF INSIDER TRADING IN DEALING WITH SECURITIES OF COAL INDIA LIMITED

(PURSUANT TO REGULATION 9(1) OF SEBI (PROHIBITION OF INSIDER TRADING) REGULATIONS 2015)

### Trading in CIL's shares by the Designated Employees – Closure of Trading Window:-

- In view of consideration of payment of Interim Dividend of financial year 2017-2018, if any by Coal India Limited Board of Directors.

As per the Code of internal procedures and conduct for prevention of Insider Trading (Code) in dealing with Securities of CIL, the Company shall specify a trading period to be called "Trading Window" for trading in the Securities. The trading window shall be closed during the time the information referred to in clause 7.3 of the aforesaid Code is unpublished. Trading window shall be opened 48 hours after the

Price sensitive information referred to in Clause 7.3 of the Code, for which trading window is closed, is made public.


It has been decided that the trading window shall remain closed from 27<sup>th</sup> Feb.'2018 to March 9, 2018 (both days inclusive). During the restricted period, the Designated Employees (as defined in Clause 2.7 of the said code and as notified vide CIL:XI(D):04161:2015:10288 dated 19/05/2015) and their dependents shall not deal in the shares of CIL.
