Common reasons for deductions of medical bills which are getting returned to the claimant of CPRMSE & CPRMSNE from PRB Cell of CIL HQ.

Subject: Reimbursement Bill for Self/Spouse under CPRMSE/CPRMS-NE Of:

Above noted claim/s is/are returned herewith for the reasons mentioned and highlighted below:

1. The Prescriptions are not from an empanelled department or empanelled hospital.
2. Complete breakup of the Final bill (item and date wise) of the hospital required
3. Claim form not enclosed
4. Undertaking/Indemnity bond enclosed to be filled up for duplicate bills submitted.
5. Claim forms not signed by retired employee.
6. Name mentioned on cash memos and prescription do not match (Patient's/doctor's name)
7. Separate claims should be prepared for outdoor and indoor claims along with CPRMSE copy, claim forms etc. in separate bunches.
8. Bills are over six months old and hence cannot be processed.
9. Invoice of the drug / injection used to be attached.
10. Proper Original bills have not been submitted, (photo copy/duplicate bills submitted).
11. Discharge certificate from hospital not attached.
12. The signature in the CPRMSE Card and the claim form do not match.
13. Separate claims to be attached for ex-employee and spouse
14. Claimed amount more than OPD limit of Rs. 25000/- for the current financial year.
15. A self-attested copy of the CPRMSE card has not been enclosed.
16. Prescription/Requisition has not been provided for the medicines/items purchased//Investigations done.
17. Medicines purchased beyond prescribed period.
18. Original invoice of the implant used in surgery along with stickers to be attached.
19. Claim form to be signed by ex-employee, not spouse
20. Others

The claim should be resubmitted after due compliance.
