Sub: Payment of Dearness Allowance (DA) @ 37.2% in respect of Board Level & Below Board Level Executives effective from 01.01.2023.

In terms of item No. V of O.M. No. CIL/C5A(PC)/Pay Revision 2017/2972 dated 08.08.2018 Dearness Allowance is payable from 1st January, 1st April, 1st July and 1st October in every year based on price increase above Quarterly Index Average 277.33 points as on 01.01.2017.

As per OM No. W-02/0039/2017-DPE(WC)-GL-I/2023 dated 04th January, 2023 issued by Under Secretary, DPE, Ministry of Finance, Govt. of India and in reference to para 7 and Annexure-III(B) of DPE's OM dated 03.08.2017 wherein the rates of DA payable to the Board level and below Board level executives and non-unionized supervisors of CPSEs have been indicated, the rates of DA payable to the executives and non-unionized supervisors of CPSEs is as under:

DA Rate 37.2% payable w.e.f. 01.01.2023

The above rate of DA i.e. 37.2% would be applicable in the case of IDA employees who have been allowed revised pay scales (2017) as per DPE O.Ms. dated 03.08.2017, 04.08.2017 & 07.09.2017.
