Subject: Documents to be sought from Non-CPSE (Private) Fertilizer (Urea) units seeking renewal of their expiring FSAs

The optimized list of documents to be obtained from Non-CPSE (Private) Fertilizer (Urea) units seeking renewal of their expiring FSAs is as under:

1. Notarized Power of Attorney (PoA).
2. Certified true copy of Board Resolution/ Shareholders Resolution etc.
3. Self-attested copy of valid Factory License of EUP or copy of the application filed for renewal of the same in case of expiry. In case Factories Act not applicable due to number of workers employed then an affidavit cum undertaking to the effect that the said unit does not qualify as a factory under the provisions of the Factories Act as per stipulations under section 2(m) of Factories Act regarding number of workers/ is to be submitted in the prescribed format by respective Coal Co.
4. Self-attested copy of CTO of EUP issued under the relevant pollution control laws or copy of application filed for renewal.
5. Self-attested copy of GSTIN and PAN
6. Valid SSI/industrial registration certificate
7. Documentation with respect to existing coal linkages, assurance of linkages and/or allocation of mine
8. Security deposit
9. Recommendation of FICC that requirement of the unit still exists and the earlier linkage granted to the unit may be extended
10. An undertaking on appropriate value of stamp paper as per **Annexure-A** that the consumer will only produce Fertilizer (Urea) from the coal supplied under the FSA.

Abovementioned documents need to be self attested by the FSA Signatory/Company Secretary of the concerned Non-CPSE (Private) Fertilizer (Urea) unit.

That, we also undertake that no coal block has been allocated for the End Use Plant (EUP) covered under the above mentioned FSA i.e. **FSA No.**

That we also undertake that in case of any discrepancy with regard to usage of coal released under the above FSA and/or with regard to statements made herein above, is/are detected or noticed by, at any point of time, shall have the right to suspend the supplies and take appropriate action as may be deemed fit.

That, apart from the above, we hereby undertake to fully indemnify (Seller) against any loss, damage or consequences in any manner, arising out of any eventuality of Procurement/ Utilization of Coal in condition of non-performance of the obligations under this Undertaking.
