This is reference to Notice No.CIL/M&S/Linkage Rationalization(4th Round)/637 dated 22.12.2025 vide which Proposed Rationalized Matrix for Linkage Rationalization (4th Round) was notified with request to concerned GENCOs to submit comments, if any, on it to enable the issuance of final matrix.

Comments received have been perused and are regarding quantity calculation. However, it is re-iterated that the rationalized quantity has been arrived at considering CEA norms for ACQ (Non-pit head) dated 08.03.2024. Accordingly, the matrix remains unchanged.
