- (ii) with Five (5) years', service in the grade rendered after appointment hereto on a regular basis in posts in the Level 12 of the Pay Matrix (Rs.78,800-2,09,200/-) or equivalent in the parent cadre/department; and
 - (b) possessing the following educational qualification and experience as prescribed in the RR.

Essential -

- (i) Bachelors' Degree in Engineering or Technology (Mining) from a recognized University/Institute or equivalent;
- (ii) Eleven (11) years' experience in Coal Industry in the Government Sector.

Desirable Qualifications:

- (i) Master's Degree in Engineering or Technology (Mining) or Masters in Business Administration.
