The allocation of Subsidiary/CIL is done based on available vacancy/requirement at CIL & Subsidiary.

Please note that the engagement in CIL/Subsidiary will be subject to being declared successful in the DV and engagement will commence from the date of reporting at final place of posting.

It may further be noted that in case the candidate fails to produce the required document/s on the date of DV, his/her candidature will stand cancelled immediately without any further notice.

In case a candidate seeks an extension of the joining period, he/she may apply for an extension of up to three (03) months i.e. up to 03.11.2026, by submitting a request to internship.cil@coalindia.in. No extension beyond three (03) months shall be permitted. In case candidates fail to join at the assigned place of posting **within 03 months of posting**, his/her candidature will stand cancelled immediately without any further notice.

10	Applicable for PwD candidates: Copy of Disability Certificate in prescribed format. Format is enclosed at Annexure-D for reference
11	Applicable for Land Owners: Proof/Certificate of Land Ownership signed by concerned Project Officer/Agent/Area GM of the Project
12	Applicable for Ward of Employees: Self-attested certificate attesting to the fact that they are wards of employee of CIL/Subsidiary who were on roll as on 01.12.2025 OR who died while being on roll & whose children have not been offered Compassionate employment, along with document/s confirming the employment status of their parent(s) in CIL or its Subsidiary
13	In case there is any discrepancy in the spelling of the candidate's name as reflected in the application and the certificates submitted (viz. Proof of Date of Birth, Intermediate Certificate or SC/ST/EWS/OBC (NCL)/PWD certificates), the candidate shall be required to submit an Affidavit stating that the name appearing in the certificates and the application pertains to one and the same person and belongs to him/her.
