Recruitment of Medical Officers as Sr.Medical Officer & Specialist in E3 Grade and Sub: Sr.Specialist in E4 Grade respectively.

The Board of Directors of CIL in their 277th meeting held on 30.01.2012 has approved the following :

- Recruitment of Medical Officers who are MBBS/BDS & who possess specialist qualifications with less than 3 years experience as Sr.Medical Officer will be in E3 Grade; recruitment of persons having Post-Graduate qualification / Specialisation with 3 years experience will be in E4 Grade.
- Specialist doctors without any experience who join in E3 grade, will be kept in Specialist ii. Cadre; their career progression will be in the same cadre.
- Medical officers & Specialist who were appointed on or after 01.01.2007 in E2 and E3 iii. grades shall be deemed to have been notionally appointed in the E3 & E4 grades respectively and their pay will be fixed appropriately.
- Medical officers & Specialist who were on the rolls on 01.01,2007 in E2 and E3 grade will be deemed to have been in E3 & E4 grade respectively w.e.f 01.01.2007. They will be entitled ίV. for notional seniority and notional pay fixation accordingly.
- All the provisions of Common Coal Cadre regarding recruitment, regularisation, closure of probation etc to be amended as per the policy mentioned above and
- No arrears will be paid on account of such up-gradation and/or notional fixation. ٧İ.

Accordingly , (a) the revised Cadre Scheme in respect of Medical Discipline is attached, (b) the service conditions of existing executives in Medical discipline be regulated accordingly and (c) necessary amendments are being made in the relevant clauses of Common Coal Cadre.

This will be effective from 1st April 2012.
