Sub: Revised Rate of DA for the Contractor Workers engaged in Mining Activities

The Ministry of Labour & Employment vide Order no.: F.No. 1/13 (2)/2017-LS-II dated 6th October 2017 informed that there shall be no increase in Variable Dearness Allowance for the period of 01.10.2017-31.03.2018 due to decrease in the average Consumer Price Index for the period January, 2017 to June, 2017 for the workers employed in Industrial Workers as thereby resulting in the VDA remaining the same as it was during the period of 01.04.2017 to 30.09.2017.

Accordingly, in terms of clause (b) of Recommendations of High Power Committee (HPC), the rates of Variable Dearness Allowance including rates of Wages for Contractors' Workers engaged in Mining activities as per the recommendations of HPC, in which it is defined under Section 2 (h), (j) and (k) of Mines Act, 1952 including Washery, CHP and Railway Sidings, the rate of VDA payable per day w.e.f. 01.10.2017 (i.e. from 01.10.2017 to 31.03.2018) would be same as it was for the period of 01.04.2017 to 30.09.2017 which is given herein below:-
