## Sub: Revised Rate of DA for the Contractor Workers engaged in Mining Activities

Further to the Office Order Reference No.: CIL/C-5B/JBCCI/HPC/VDA/651 dated 23.04.2018 notifying the revised rate of VDA for the Contractor Workers engaged in Mining Activities w.e.f. 01.04.2018 & letter reference no.: CIL/C-5B/JBCCI/HPC/VDA/761 dated 27.06.2018 inter alia for keeping the aforesaid Office Order on hold; the matter has been rechecked and verified with regard to calculation of VDA for contractor worker.

Accordingly, in terms of clause (b) of Recommendations of High Power Committee (HPC), the rates of Variable Dearness Allowance including rates of Wages for Contractors' Workers engaged in Mining activities as per the recommendations of HPC, in which it is defined under Section 2 (h), (j) and (k) of Mines Act, 1952 including Washery, CHP and Railway Sidings, the rate of VDA payable per day w.e.f. 01.04.2018 (i.e. from 01.04.2018 to 31.10.2018) would be as under:-
