Dear Secretary,

You may be aware that the Quality Council of India (QCI) has been established through a Cabinet Resolution in 1996 as the National accreditation body. The Cabinet mandated that the Government would increasingly depend on conformity assessment bodies accredited by the National Accreditation Boards for products and Quality Systems Certification functioning under the umbrella of the QCI.

- QCI is entrusted with the task to monitor and administer the National Quality Campaign. Consequently, National Accreditation Boards for Testing and Calibration Laboratories (NABL), Certification & Inspection Bodies (NABCB), Hospital & Healthcare providers (NABH), and Education & learning service providers (NABET) have been established under QCI.
- 3. It has come to our attention that several conformity assessment bodies (labs, inspection bodies, certification bodies, etc.) are operating in India and issuing certificates at times without transparency, accountability and oversight. Such practices severely impact the traceability of conformity assessments, thereby affecting India's brand identity in both domestic and foreign markets.
- 4. In light of the above, I would request that you may consider issuing instructions to departments, attached/subordinate offices/PSUs under your purview to utilize the national accreditation body for the purposes of accreditation of agencies under your department's purview.
