For any deviations from Indian Standards or for any additional parameters for better performance, specific reasons for deviations / modifications should be duly recorded with the approval of the competent authority."

The Bureau of Indian Standards (BIS) is mandated under the BIS Act, 2016, to formulate Indian Standards, promote their use and adoption, and implement an effective mechanism for ensuring compliance with the standards.

- 2. Standards play a key role in the economic development of a country by creating a quality eco-system. It is, therefore, vital that larger number of Indian Standards are brought within the ambit of the conformity assessment schemes of BIS. Many such products and processes can be identified through coordination between the Ministry and BIS. Regular interaction between BIS and stakeholders from the Industry as well as Research Organizations under the aegis of your Ministry, would go a long way in boosting activities related to standardization and certification of products.
- 3. I would also like to draw your kind attention to the usage of Indian Standards. Several PSUs and Government Organizations are using standards formulated by private or international bodies even for the products for which Indian Standards exist. There are instances of their referring to non-Indian Standards in their procurement processes, which is disadvantageous for the Indian manufacturers who are producing goods as per Indian Standards.
- 4. It is requested that appropriate instructions regarding procurement of goods as per Indian Standards may kindly be issued. BIS would coordinate with the Ministry for this purpose, as also for organizing Stakeholder Workshops to identify products and processes that can be standardized.
