Sir,

The undersigned is directed to refer Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 and its subsequent amendments, which directs to all Central Government Ministries, Departments, and Central Public Sector Enterprises (CPSEs) for mandated procurement of a minimum of 25% of their annual procurement of goods and services from the MSEs.

2. As per clause 11 of the order, there are 358 items reserved for exclusive purchase from the MSEs as mentioned in the Appendix to the order. The Appendix items at **SI. No. 351 (Cane Furniture, Handlooms) and 352 (Bamboo File Tray, Baskets, Pencil Stand, Side Racks, etc.)** have been reserved for exclusive procurement from the following organizations:

**North Eastern Handicrafts and Handlooms Development Corporation (NEHDDC),  
 Assam Govt. Marketing Corporation.,  
 Craft Society of Manipur, and  
 Nagaland Handicrafts and Handlooms Development Corporation.**

NEHHDCL, a CPSE under administrative control of M/o Development of North Eastern Region, is the designated nodal agency for promoting and marketing cane, bamboo, handloom, and handicraft products of the North Eastern Region. **Procurement from NEHHDCL is currently considered equivalent to procurement from MSEs.**

3. Accordingly, all CPSEs, are suggested to consider procurement of the above-mentioned items from either of above-mentioned organizations (including NEHHDCL) to meet the target of procurement obligation under the Public Procurement Policy for MSEs, 2012 (amended 2018) i.e. 25% from MSEs with sub-targets of 4% from MSEs owned by SC/ST entrepreneurs and 3% from MSEs owned by women entrepreneurs.
