ORDER

In pursuance of letter No. 21/23/2019-BA dated 31.07.2020 from Under Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying approval of the President and in pursuance of Articles of Association of Western Coalfields Limited (WCL), Shri Rajendra Prasad Shukla, General Manager, South Eastern Coalfields Limited has been appointed as Director (Finance), Western Coalfields Limited in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/- (revised) w.e.f. the date of his assumption of charge of the post till the date of his superannuation i.e. 31.12.2021 or until further orders, whichever is earliest subject to the final outcome of WP(S) No.10800 / 2019 along with condition that after the expiry of the first year the performance of Shri Shukla will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shukla takes over charge of the said post. However, his appointment as Director (Finance), WCL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.

No. 18(21)/98-GM-GL-73 dated 20th October, 2005, if Shri Shukla does not join the post he shall be debarred for a period of two years from the date of offer of appointment, from being considered for Board Level posts in any CPSE. The debarment would be applicable to all CPSE's other than the one to which the candidate belongs.

Detailed terms and conditions of appointment of Shri Shukla as Director(Finance), WCL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

The appointment of Shri R.P. Shukla is subject to the final outcome of WP(S) No.10800/2019 in the High Court of Chhattisgarh.

Shri R.P. Shukla, will assume the charge of the post of Director (Finance) WCL in Schedule 'B' of CPSE in the pay of Rs.1,60,000-2,90,000/- (revised) and accordingly submit his joining report to Chairman-cum-Managing Director, WCL under intimation to Chairman-cum-Managing Director, CIL and Ministry of Coal.
