The promotion will be effective on and from the date the above executives actually assume charge of the higher post. Further assignment of promoted executives will be decided by the CMD of the respective subsidiary company. The executives are granted Notional seniority with Notional fixation at par with those who promoted vide office order no CIL/C-5A(CC)/Prom. E5-E6/Min 1<sup>st</sup> Cls/B-532 dated 09.09.20.
