### ORDER

Sri S.K. Somani, 90037706, (DOB : 25-Nov-1962), Chief Manager (Finance), ECL, in E-7 grade is hereby promoted to the post of General Manager (Finance) in E-8 grade in the scale of pay of Rs. 1,20,000-2,80,000/- and posted in his present place of posting, till further orders.

On promotion, Sri S.K. Somani will be on probation for a period of one year at the first instance.

The promotion of the above executive will be effective on and from the date he assumes charge of the higher post at ECL. Further assignment will be decided by the Chairman-cum- Managing Director, ECL.

On assumption of the charge of the higher post, the aforesaid executive will be entitled to notional seniority and notional fixation at par with executives promoted from E7 to E8 grade vide order no. CIL/C-5A(V)/DPC/E7 to E8-20/2021/Fin./B-469 dated 16.06.2021 and consequent upon such notional seniority, Sri S.K. Somani will be placed below Sri R Baskaran (90122656) and above Sri AK Mishra (90116500). However, the actual financial benefits shall accrue to him only from the date of assumption of charge of the promoted post.

Sri S.K. Somani has to join the promoted post within 60 days from the date of issue of the order, failing which the Promotion Order shall stand cancelled abinitio.

This order shall abide by the ultimate adjudication in the Writ Petition nos. 19607(W) of 2017 with no. 9754(W) of 2017 (Bani Singh Rana & Ors. with Pijush Kumar Singha & Ors. vs CIL & Ors.) before the Hon'ble High Court of Calcutta.
