## ORDER

In pursuance of letter No. 21/8/2020-ESTABLISHMENT dated 03.02.2022 from Under Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Bharat Coking Coal Limited (BCCL), Shri Sanjay Kumar Singh, General Manager(GM), Central Coalfields Limited(CCL) has been appointed as Director(Technical), Bharat Coking Coal Limited (BCCL) in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/-(revised) with effect from the date of his assumption of charge of the post till the date of his superannuation, i.e. 30.06.2023, or until further orders, whichever is earliest subject to the condition that after the expiry of the first year the performance of Sri Singh will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shri Singh takes over charge of the said post. However, his appointment as Director (Technical), BCCL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.

As stipulated in DPE's O.M. No. 18(21)/98-GM-GL-73 dated 20th October, 2005, if Shri Singh does not join the post he shall be debarred for a period of two years from the date of offer of appointment, from being considered for Board Level posts in any CPSE. The debarment would be applicable to all CPSE's other than the one to which the candidate belongs.

Detailed terms and conditions of appointment of Shri Singh as Director (Technical), BCCL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

The appointment of Shri Sanjay Kumar Singh is subject to the final outcome of WP(S) No.10800/2019 in the High Court of Chhattisgarh.

Shri Sanjay Kumar Singh will assume the charge of the post of Director (Technical), BCCL in Schedule 'B' of CPSE in the pay of Rs.1,60,000-2,90,000/-(revised) and submit his joining report to Chairman-cum-Managing Director, BCCL under intimation to Chairman-cum-Managing Director, CIL and Ministry of Coal.
