## ORDER



On promotion, the Sri A. Singh will be on probation for a period of one year at the first instance. The promotion of Sri A. Singh will be effective on and from the date he actually assumes the charge of the promoted post at ECL. Further assignment will be decided by the Chairman-cum- Managing Director, ECL.

However, the actual financial benefits shall accrue to him only from the date of assumption of charge of the promoted post.

Sri A. Singh has to join the promoted post within 60 (sixty) days from the date of issue of the order, failing which the Promotion Order shall stand cancelled abinitio.
