ORDER

In pursuance of letter No. 21/11/2022-ESTABLISHMENT dated 09.12.2022 from Under Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association Eastern Coalfields Limited (ECL), Shri Nilendu Kumar Singh, General Manager, South Eastern Coalfields Limited(SECL) presently posted at Eastern Coalfields Limited(ECL), has been appointed as Director(Technical), Eastern Coalfields Limited (ECL) in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/- for a period of five (05) years with effect from the date of his assumption of charge of the post or until further orders, whichever is earlier subject to the condition that after expiry of the first year, the performance of Shri Singh will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.

His appointment to the said post will be effective from the date on which Shri Singh takes over charge of the said post. However, his appointment as Director (Technical), ECL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.
