## ORDER

In pursuance of letter No. 21/4/2025 ESTABLISHMENT(B) dated 31.10.2025 from Section Officer to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Bharat Coking Coal Limited, Shri Rajeev Kumar Sinha, General Manager, Bharat Coking Coal Limited, has been appointed to the post of Director(Technical), CMPDIL in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/- w.e f the date of his assumption of charge of the post till the date of his superannuation i.e 31.12.2028 or until further orders, whichever is earlier subject to the condition that after the expiry of the first year the performance of Shri Rajeev Kumar Sinha, will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of his tenure.

Shri Rajeev Kumar Sinha will assume the charge of the post of Director(Technical), CMPDIL in Schedule 'B' of CPSE in the pay of Rs.1,60,000-2,90,000/- (revised) and submit his joining report to Chairman-cum-Managing Director, CMPDIL under intimation to Chairman-cum-Managing Director, Coal India Limited and Ministry of Coal.
