General Guidelines for Web based VC

1. All the participants shall be needed to download and install Webex client software in their laptop/desktop for the first time.
2. To connect using Desktop / Laptop etc., all participants may join by clicking the web-link. It may be ensured that there is good web-camera and microphone-cum-speaker and high speed internet connection in order to get a good quality audio-video from all participants.
3. All the participants who are invited to attend the session through web-link need to test their PC/laptop/devices etc., by connecting well in advance ahead of their allotted time to ensure that their device is properly configured with the software and if any issues are encountered, they can be dealt with well in advance to avoid any last minute problems.
4. All the participants should connect the VC session from their location 30 minutes prior to their scheduled time.
5. All participants are required to keep their MICROPHONE Muted to avoid disturbances in the VC meeting. Participants not following the same may be disconnected by the administrator in case of continuous disturbance.
6. Camera position should be zoom in mode covering clear visibility of the participant according to the coverage angle of the camera.
7. Single participants should not join from multiple devices from same location. The participants so connected may be disconnected/disallowed by the host/administrator.
8. Participants are advised to use wired earphones/headphones for better audio quality.

"Participants should not attempt to join the VC through Web-link from Smartphones/ other Mobile Wi-Fi devices."
