Ministry of Coal has vide OM no. 301/2/2020/NA dated 19.01.2022 forwarded the DPIIT DO letter No. P-25020/10/2020-EODB dated 10.01.2022 for reducing or simplifying unnecessary interfaces and complex procedures. Keeping in view the above objective, the following Systemic Improvement Measures in procurement are issued with approval of Chairman, CIL for information and compliance:

1. The following declarations / certificates / information required to be submitted / furnished by the bidder along with their offers in tenders for goods and associated services under the purview of Purchase Manual shall be made part of "Commercial Parameter Sheet" (CPS) and no separate document in respect of the same is required to be submitted by the bidder:

- 3. While indenting electrical appliances like AC, Refrigerators etc with BEE rating as a part of technical specifications, care should be taken by indenting department to indicate the year / period of BEE star rating also in the technical specifications, to ensure that product & BEE rating is not obsoiete (Ref: Purchase Manual Chapter 4, Clause 4.1.4)
- 4. The guidelines regarding import of Equipment and P&M items on CIP basis has been issued vide Office order no.1643 dated 08.06.2020. The procurement of imported Equipment & P&M items shall be made on CIP basis as far as possible. Where there is no other option but to procure on FOB basis, reasons for procurement on FOB basis shall be recorded while seeking approval for floating the tender.
- In order to provide flexibility to the supplier, option to submit subsidiary wise Bank Guarantee shall be provided in cases of procurement of OTR Tyres by CIL(HQ).

6. All Subsidiaries shall ensure timely issuance of "No Claim Certificates" for facilitating timely release of Bank Guarantees.
