It has been decided by the CIL Management to amend **Clause 11.8.3 (Cash – Financial Coverage)** of the CIL e-Auction Scheme 2022 . Accordingly, the following amendment is hereby issued:

11.8.3 (Cash – Financial Coverage)	<p>"In case of submission of Bid Security in the form of cash, coal value shall be deposited considering the Bid Security amount i.e. coal value to be deposited and Bid Security amount taken together shall be equivalent to the 100% coal value as per clause 6.1 of the scheme.</p> <p>The differential amount as mentioned in 11.8.3 above shall be furnished by Demand Draft/Pay order/e-transfer, referred to as cash prior to signing of tripartite agreement."</p>	<p>"In case of submission of Bid Security in the form of cash, coal value shall be deposited considering the Bid Security amount i.e. coal value to be deposited and Bid Security amount taken together shall be equivalent to the 100% coal value as per clause 6.1 of the scheme.</p> <p>The differential amount towards Financial Coverage may be furnished either in the form of (a) Demand Draft/Pay order/e-transfer (cash), or (b) Bank Guarantee/e-Bank Guarantee (BG/e-BG) valid for a minimum period of six months or till final settlement, whichever is later.</p> <p>In case of shortfall in Financial Coverage, additional BG/e-BG or Cash shall be furnished over and above the Bid Security."</p>

All other terms and conditions of the CIL e-Auction Scheme 2022 shall remain unchanged. This is being issued with the approval of competent Authority
