In pursuance of letter No. 21/6/2022-ESTABLISHMENT dated 21.02.2023 from Under Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Bharat Coking Coal Limited(BCCL), Shri Murlikrishna Ramaiah General Manager, Steel Authority of India (SAIL) has been appointed as Director(Personnel) Bharat Coking Coal Limited(BCCL),in Schedule 'B' of the CPSE, in the scale of pay of Rs.1,60,000-2,90,000/- for a period with effect from the date of his assumption of charge of the post till the date of his superannuation i.e 31.08.2026 or until further orders, whichever is earlier subject to the condition that after the expiry of the first year the performance of Shri Ramaiah will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.
